  - Business address to be registered within the NLM (No changes within the last 2 years)
- 7. Three Completion Certificates of Similar Works (not older than 3 years)**

## **Post-Appointment Requirements**

Upon appointment, the selected subcontractors will be required to provide:

- 1. Health & Safety File**
  - A comprehensive health and safety file in compliance with the Occupational Health and Safety Act.
- 2. Valid Medical Certificates for All Employees**
  - Medical certificates for all employees to ensure they are fit to work on the construction site.
- 3. Personal Protective Equipment (PPE) for All Employees**
